Cliff Schmidt has once again been contracted for 80 hours in 2008 for the week of July 14th.

In the past, our primary concern focused on Elodea, Narrow Leaf Pond Weed, and Curly Leaf Pond Weed. With discovery last fall of Eurasian Water Milfoil, we all need to be on the lookout for it and carefully uproot the entire plant. Eurasian Water Milfoil, and Curly Leaf Pond Weed (most active when ice is going out) plagues many of our northern lakes. We need to be especially vigilant of the boat landing for signs of the Eurasian Milfoil, as that's where most of our off-lake boats enter the lake

It should be noted that if weed cutting is not needed, we are allowed to cancel our contract and save the money.

From the Chair

Since our survey is fresh in our minds, I thought I'd write about a few of the comments.

In the first week after we mailed our 100 lake surveys, lots came back. Then it tapered off and we now stand at fifty. We were hoping to get most of them back. Then we talked to people who are more familiar with sending out surveys. They said if we get back one-third we're doing well. So, we've read all the comments and are tabulating the other information to get a clearer picture of what our needs and observations are about the lake.

We had quite a few people express an interest in limiting the number of fish caught on our lake - especially Northern. Our lake has a daily limit of five but it isn't enforced very well. Personally, I catch and release the ones I bring in because I want to preserve the fish

numbers on our lake. It has been suggested that we set more restrictive limits - even size limits, on Northern caught. We looked into that but found out that it takes about three years and involves attending a oncea-year DNR meeting in Rhinelander, getting a resolution approved to present to the legislature, and then getting it signed into law. I have given my blessing to anyone who has the time and energy to shepherd this through, but nobody has taken me up on it. I'm all for it, though.

We had a couple of suggestions to dredge the lake to make it at least 15-20 feet deep. In the 1970's someone looked into it. That plan was estimated to cost \$1,000,000 then. I'm sure the DNR would have something to say about disturbing the ecosystem if we decided to pursue it. Enough said.

One person said, "Don't you dare raise our taxes again". My first thought was that someone thinks the commissioners raise District taxes. Actually, it is the people who

attend the annual meeting who make that determination. The commissioners explain what our finances are and make recommendations. The District residents at the meeting set the budget by picking and choosing what they want to spend money on. In the past several years, we've had bumper crops of weeds to deal with. From comments, discussion, and motions made, it's obvious that our residents want to enjoy the lake when they come to visit. Unfortunately, weed cutting isn't cheap. I, for one, have appreciated the spirit in which our residents gather at the annual meeting to consider the issues before us. Since I

issues before us. Since I have been the Chairperson, I have been impressed with the careful thought, and spirit of cooperation. It is evident that we share responsibility for the lake's care.

May the coming summer season be enjoyable and safe for all who come to enjoy our lake.
