### Outlot Owner Change

The new owner is Dennis Lanphear of Arbor Vitae. Though he says he will honor the lake access guarantee written into 7-9 of our resident's deeds, he has asked several of them to relinquish this right. At least two have refused.

He did make a recent proposal to allow the harvester and loading for one week a year, with the provision that our District persuade deeded accessholders to give up their rights for the harvesting time and for the District to pay for weed clean-up at his landing. District leaders have refused since the owners would likely be giving up any accumulated "adverse possession" rights to the access.

The lot never belonged to the District, as many assumed. A private investigator discovered in 2006 that it belonged to a couple living in Maryland, the Geralds. The couple paid taxes through 2008, but not since. They did give verbal okay to the District to use the lot for weed harvesting.

At our annual meeting, the District formed a Outlot Task Force Committee to look into our options. Most agreed that, longterm, owning the lot would be best for the District. In the meantime, we are looking into an alternative site. Cliff Schmidt has told us he will not issue a contract for 2014 until the issue is resolved.

### Lake Study Grant

Our latest lake grant to assess our lake for invasive species has been completed.

Researches found Curly-leaf Pond Weed, which has been in our lake for some time. It has not expanded significantly because conditions are not favorable for the weed, it poses only a small threat.

The most important finding was the location of Eurasian Water Milfoil in about six locations; mostly near the two boat landings. Because the report listed the GPS locations, divers went out on July 14<sup>th</sup> to carefully pull the weeds from the lake floor, which took three hours' time at a cost of \$225.

Our study recommends a repeat of the lake study every 3-4 years. Money has been set aside in our current budget for further diving efforts.

Total cost of the lake study was \$3,487. The state has covered 75%. To date, the District has received all but 10% of our reimbursement.

### Lake Water Testing

Lake data for 2012 reveals that our lake is just inside the Eutrophic category; aging a bit faster than we would like. In 2011, the Trophic State Index (TSI) was 53. Currently at 52, we are slightly better, but it varies from year to year. Secchi readings show an average clarity depth of 7.5 feet, while last year it was only 6 feet. August is usually when we see an abundance of algae in the lake, but not his year.

Mike and Kim Esler have volunteered to continue our lake testing for official DNR reporting in 2014. This will be their 3<sup>rd</sup> year in the important role.

## Aerator Maintenance

Prior to the onset of ice, the aerator will be inspected and serviced to help ensure its continued service throughout the winter.

It should be noted that it would cost nearly \$6,000 to replace the compressors. They have reached their normal expected life span, therefore, we have begun to set aside money for replacement.

# Clean Boats/Clean Waters

Our new Clean **Boats/Clean Waters** volunteers for 2013 are Terry & Hallie Moline. They deserve our thanks for the valuable preventive invasive weed program. Hallie reported that all the boaters & fishermen have been very friendly and cooperative. One person gave her a \$20 donation to help with District expenses. She also reported that fishing has been down this season.



Maximum acreage allowed by our permit is 60 acres. Comments made at the annual meeting favored cutting the weeds during the second week of August instead of the 3<sup>rd</sup> week. One-hundred hours has been budgeted for 2013.

> Be sure your boat has NO plant material attached when you launch your boat in Horsehead Lake or take it out. Leaving it out of the water for a full week will substitute for washing with soap.
