### FISH KILL

When the ice went out on April 11<sup>th</sup>, it became apparent that a sizeable fish kill had occurred during the winter.

While our aerator does not altogether prevent such occurrences, it does help to minimize them.

Four factors affect the oxygen level of a lake:

- 1) snow depth on ice
- 2) ice thickness
- extreme cold weather And,
- chemical decomposition of weed biomass which uses up oxygen.
   Most of the fish were 1-2" Bluegills, but there were some nice-sized Bass and Crappies as well.

The fish have been seen along the SE, NE, NW, and SW shores.

The problem only underscores the need to address the weed situation ASAP.

## "Clean Boats, Clean Waters"

It won't be hard to notice our volunteers (Kris Batchelet, Pat Donnick, & Joanne Erickson) at the boat dock. They'll be wearing Royal Blue T-shirts and they'll be checking to see if boats and/or trailers have weeds or mud attached. So far. Horsehead Lake DOFS NOT have the dreaded Eurasian Water Milfoil, but we do have areas of Curly-Leaf Pond Weed. The best time to notice it is just after the ice goes out. It grows thick and makes motoring difficult.

Keep watch for it and notify one of the commissioners if you see it. You can also see the small "turions" in the shallows. If you step on one, you'll say "ouch".

## What You Can Do To Help

 Be on the alert for Curly-Leaf Pond Weed and Eurasian Water Milfoil Plants. If you find Curly-Leaf Pond Weed in your beach area, pull it out by the roots. It is the cheapest and most effective way of getting rid of this near-shore invasive.

- Urge you neighbors to be diligent in their efforts to get rid of invasives and protect our lake.
- Wash your boat with soap and water whenever re-launching from a nearby lake.

## From the Chair

We were very disappointed to hear about our DNR grant proposal being denied. By way of explanation, there is a great deal of competition for these grants, especially since more lake associations are applying for them. In addition, the legislature has reduced the funding for the grants by about 50%. Money is tight in Madison.

There is an elaborate ranking process that awards points to various facets of each submitted proposal. Then, all proposals are ranked numerically from top to bottom. When the final results were announced, ours would have been the next funded.

But all is not lost. In August, an equal amount of grant money will be available when we will re-submit. In the meantime, Tim Hoyman, our weed consultant, will be

working closely with DNR staff to make minor modifications to our proposal. We are hopeful that our proposal will then be accepted. The downside is that work on our lake study cannot begin until the ice clears in 2007. Until then, we will have to be clever in thinking of ways to minimize the effects of excessive weed growth and the resulting additional biomass that will be created in the lake.

Anything you can do to prevent the decaying weeds from mixing with clean water and lake vegetation, will go a long way toward helping our situation. Slower boat traffic would help.

I am confident that, working together, we can devise a plan that will eventually solve our problem.

### Did you know?

Loons are "snow birds", too! They spend the winter in coastal areas of the Deep South from North Carolina to Texas.
