District Members

Beavers affected the lake level recently when approximately 6 inches of rain could not easily escape from the lake due to a large number of branches they placed near the dam. The lake level reached levels we haven't seen for several years. Some like the water level high while others are not so pleased when they begin to lose their shoreline. We urge residents to keep an eye on the dam and report obstructions to the Town of Lake Tomahawk so they can remove branches before we have a serious problem.

No rain was recorded in the area for over a month, producing drought conditions and an extreme fire hazard. The good side of that was, of course, NO MOSQUITOES! So it just goes to show that nothing is all bad. Keep your fingers crossed.

Many members have reminded me that no summer is the same on Horsehead Lake. Perhaps that's what makes living on or near a lake so fascinating. Something is always different.

As we drift slowly into fall, and begin to see the seasons change, sit back and appreciate the biological "symphony" that is "playing" for our enjoyment.

Annual Meeting Notes

- Despite the moderate fish kill over the past winter, our aerator did work to protect many fish and prevent a more drastic result.
- Statistically, the DNR reports our lake's chemistry is virtually the same as last year, with only a very slight decrease in quality of the water. (see web page link to DNR)
- Noted that 81 loads of vegetation were removed from our lake by Schmidt's Landscaping representing

- about 25,000 cubic feet of weeds at a cost of \$9,000.
- Passed our 2006-'07 budget calling for a \$13,500 levy, 60% of last year. This will allow for 80 hours of weed cutting compared to 56 hours this year.
- Budget maintains \$6,000 to cover our portion of DNR grant proposal.
- Voted to continue membership in Wisconsin Association of Lakes & Oneida Co. Lakes and Rivers Association.
- Voted to allow commissioners to decide whether or not to cut weeds next summer.
- Voted to authorize inspection & maintenance of aerator in the fall.
- Voted to create a \$500 Contingency
 Fund to cover unanticipated expenses.
- Voted to alter bylaws to improve gender-specific language & formally

- disallow mail-in nominations and balloting.
- Elected Beverly Fagan to another term as commissioner.
- Dennis Batchelet, Linda Houghton-Bowen & Beverly Fagan renewed as Chairperson, Secretary, and Treasurer, respectively.
- Announced next Annual Meeting date on August 18, 2007.

Curly-Leaf Pond Weed

It's the only invasive
Horsehead Lake has, so be on
the lookout for it. Watch for
the curly (wavy) leaves in your
swimming area and carefully
pull it out by the roots. You
must dispose of it on land. You
can also see the small
"turions" in the shallows. They
are somewhat sharp and
shaped like a small pinecone.

Eurasian Water Milfoil

So far, this invasive weed is NOT in Horsehead Lake, but we must be vigilant. Learn what it looks like and urge your neighbors to do the same. REPORT ANY DISCOVERIES to a commissioner.

If you have had your boat in an infected lake, BE SURE TO WASH IT WITH SOAP & WATER before re-launching in Horsehead Lake. This cannot be emphasized enough!

Columnaris Bacteria

After Memorial Day, residents began seeing large numbers of dead fish floating near their docks. The fish were afflicted by bacteria named Columnaris. Joanne Erickson and Jack Houghton have researched this disease and have provided information

they gained from DNR fish biologists.

Fortunately, the disease is not harmful to humans, but it affects primarily Bluegill, Crappies, Yellow Perch, Bullheads, Bass, and Northerns to a lesser degree.

It happens shortly after spawning time when the fish are in a weakened condition and the water temp rises rapidly to 65-70 degrees in May-June. During that time, bacteria levels rise after major rainfalls have washed nutrients into the lake, which the bacteria thrive on.

Though large numbers of fish can be affected in just a few days, it usually does not have a catastrophic effect on the overall fish population of a lake. Unfortunately, it can be a big mess to clean up.

Weed Cutting

We will apply for another weed cutting permit next year, just in case it is needed. Under new DNR rules, lakes will be permitted to cut weeds only three times without a Lake Plan on file and we've used at least one of ours already. That's one reason why we need our lake study grant so we may develop our plan. We have contracted with Schmidt's Landscaping again to cut weeds during the 3rd week in July, unless we cancel. DNR Tree Harvesting

Within the past month, we have learned, through Don and Carol Niebler, of a DNR plan to continue harvesting trees on the NW area of the lake, up to Kania's property. We are investigating the reasons for the cutting and will report in the web page what we find out.

We will be urging the DNR to allow us some input on the process so as to minimize the impact on our residents.

reduce the wave action close to shore that can damage our shoreline. Maintaining a 100-foot buffer near piers would help in that regard. There has been an increase in the number of larger boats with bigger motors. Since early spring, there have been fewer fishermen on the lake.

As we move from late summer into fall, I hope the weather continues to be favorable for those visits from family and friends and that your good times keep rolling on.
