The meeting was called to order at 6:05 p.m. By Commissioner Dennis Batchelet in the Peterson Room of the Sloan Center, Lake Tomahawk, Wi.

Notice of the meeting was posted at the post office and the Sloan Community Center. All commissioners were sent notices and copies of the agenda.

Motion to approve the agenda was made by Mike Esler and 2<sup>nd</sup> by Matt Michalsen. Motion carried.

Presidents Report: Dennis stated that Stuart Utley, one of our lake residents, was working on getting our website changed over to a new format and getting it updated. He state that Stuart was very busy but that he would try to get it updated as soon as possible. Dennis also said he talked to Cliff Schmidt, our weed harvester, and told him that at this point there were no masses of weeds floating on the surface of the water.
